## NEW REALITY - NEW CHALLENGES?

We are witnessing remarkable achievements: we are looking for a new place for ourselves on Mars, we are able to roll out vaccines against Covid within a year, we have huge data resources at our disposal, we may eventually be able to connect the world of quantum physics with the physics of Galileo and appreciate the importance of finding a new atomic particle for understanding our reality.

#### ECONOMIC COOPERATION OF POLAND, GERMANY AND FRANCE DURING EFNI 2021

The Polish Confederation Lewiatan together with its partners – German BDI and French MEDEF is the initiator of the Weimar Economic Triangle at this year's EFNI. The Weimar Triangle, i.e. Germany, France and Poland, means 193 million inhabitants and nearly 40 percent of the EU's GDP. These three countries together have the potential to be a solid binder for the development and competitiveness of Europe and its transformation to protect the climate. Regardless of the political agenda of our governments – the facts



speak for themselves: entrepreneurs from France, Germany and Poland work together to promote the flow of technological knowledge, goods and services between Eastern and Western Europe.

In Sopot, we will talk about strengthening this cooperation with a group of representatives of Polish, French and German companies as well as non-governmental organizations and scientific communities.

We will discuss what women can do together taking European affairs into their own hands, during a special edition of the Weimar Women's Triangle, which will feature prominent speakers.


